THE 2010 CENSUS

The U.S. Census counts every resident in the United States, and is required by the Constitution to take place every 10 years.

The 2010 Census will help communities receive more than \$400 billion in federal funds each year for things like:

- Hospitals
- Job training centers
- Schools
- Senior centers
- Bridges, tunnels and other-public works projects
- Emergency services

The data collected by the census also help determine the number of seats your state has in the U.S. House of Representatives.

In March of 2010, census forms will be delivered to every residence in the United States and Puerto Rico. When you receive yours, just answer the 10 short questions and then mail the form back in the postage-paid envelope provided. If you don’t mail the form back, you may receive a visit from a census taker, who will ask you the questions from the form. For more information, you may visit www.2010census.gov.

SNOW REMOVAL

A reminder that owners and occupants of property adjoining public sidewalks in Ada Township are required to keep sidewalks abutting their property free of ice and snow, within 24 hours following a snowfall event of three inches or more.

An owner or occupant may be exempt from the ordinance if the Township Supervisor determines that compliance with the ordinance would result in a physical or economic hardship. Any person wishing to claim an exemption can submit a written request to the Township Supervisor in advance of an accumulation of snow.

A NOTE FROM THE TREASURER...

You should have received a tax bill at the beginning of December. If you did not receive a bill, please give our office a call.

Since the normal due date for the winter taxes of February 14, 2010, falls on a weekend and the next business day is holiday for the Township, all tax payments this year are due in our office by 5:00pm, Tuesday, February 16, 2010. Remember **POSTMARKS ARE NOT ACCEPTED** as date received.

The usual payment options still apply; by mail, in person, by credit card (*see the reverse side of your tax bill*). Credit cards are **NOT** accepted at the Township. Additionally, you may sign up for ACH electronic payments. Please contact our office for more information about ACH.

Due to delays at the County level, dog licenses will not be available until after January 1, 2010. You may obtain your dog license at the Township from Monday, January 4, 2010 through Monday March 1, 2010. The State of Michigan requires all dogs age 4 months and older to be licensed. In order for a 2010 license to be issued, a current rabies certificate must be presented. If your dog(s) has been spayed/neutered, a written proof of spay/neuter must also be presented. You can receive a copy of these through your veterinarian.

A GREAT CHRISTMAS GIFT FOR THE ENTIRE FAMILY

An ongoing problem for all emergency service agencies is the lack of visible street numbers at the road, and on driveways with more than one residence.

Use this checklist to help determine if the Fire Department, or other emergency responders, can find your home:

- Is your house number at the street and easily visible day or night?
- Is it obvious that the numbers at the street are for your house?
- If you live on a drive with more than one residence are your house numbers posted on the public roadway and also posted at the entrance to your driveway?

A good test of the visibility of your street numbers is to ask a friend if they could readily locate your address.

Fires double in size every minute. CPR should be started within four minutes. A delay of one to two minutes in locating your residence can have dramatic consequences.

Ada Township has a Street Address Number Ordinance which also must be complied with.

The Fire Department can make green reflective address signs for \$15 each and will be happy to advise you on the placement of your house numbers. Call during office hours, 8am to 5pm, to order an address sign or to make an appointment. Our non-emergency number is 676-2376.

EXPOSING AN INVISIBLE KILLER: THE DANGERS OF CARBON MONOXIDE

National Fire Protection Association (NFPA) and Underwriters Laboratories (UL) urge families to inspect, protect and detect to safeguard loved ones from the “Silent Killer”

Bitter cold weather can bring more than just frosty mornings and runny noses. Along with the winter chill come the dangers of deadly carbon monoxide (CO), whose odorless reach extends into household living spaces as more families turn to alternative methods—such as a fireplace, wood stove or portable heater—to heat their homes and save a few dollars.

A new survey* released by Underwriters Laboratories (UL), an independent product safety testing organization, revealed that while many Americans claim they have some familiarity with the dangers of CO, many others admit their knowledge is shallow, a red flag considering CO is a significant problem in the U.S., sending more than 15,000 people to the emergency room each year (according to a 2008 study by the Centers for Disease Control and Prevention). The survey also revealed only half of Americans actually have a working CO alarm installed in their home and a whopping seventy-seven percent of American seniors believe CO can be easily detected by human senses.

Because you cannot see it, smell it or taste it, you or your loved ones could be exposed to CO without even knowing it. The symptoms—headaches, fatigue, nausea, dizziness and shortness of breath—are often mistaken for the flu.

Municipal fire departments respond to an average of seven calls an hour where CO is present, according to a 2005 NFPA report on Non-Fire Carbon Monoxide Incidents. “Each day, first responders are called upon to help people who have unknowingly been exposed to carbon monoxide and are suffering from CO poisoning,” says James Shannon, president and CEO of the National Fire Protection Association. “It is vital for people to learn how to keep themselves and their families safe from CO before they are exposed to it. When it reaches a dangerous level, its effects may leave them unable to make that life-saving call for help.”

According to the Centers for Disease Control and Prevention, more non-fire CO incidents occur in the month of January than at any other time of year. UL and the National Fire Protection Association (NFPA), an authority on fire and life safety, have teamed up to increase awareness about the dangers of carbon monoxide and urge families to INSPECT, PROTECT and DETECT when it comes to CO safety.

Have a qualified technician INSPECT fuel-burning appliances once a year

- Fuel-burning appliances such as furnaces, hot water heaters and stoves require yearly maintenance. Over time, components can become damaged or deteriorate. A qualified technician can identify and repair problems with your fuel-burning appliances.
- Avoid placing your CO alarm directly on top of or directly across from fuel-burning appliances.

PROTECT your home by purchasing and installing a CO alarm

- Purchase and install UL-LISTED CO alarms outside each sleeping area and on every level of the home, including the basement and be sure to read the manufacturer’s instructions carefully before installing the alarm.
- If you already have CO alarms installed in your home, test them monthly and replace the battery at least once a year.

Be prepared should your CO alarm DETECT a problem

- If your alarm sounds, immediately open windows and doors for ventilation and move to a fresh air location outdoors. Make sure everyone from inside the home is accounted for. Call 911 from a fresh air location and stay there until the Fire Department arrives.
- If anyone in the home is experiencing symptoms of CO poisoning—headache, dizziness or other flu-like symptoms—immediately evacuate the house, and call 911.
- Be alert to some of the danger signs that signal a CO problem:
 - Streaks of carbon or soot around the service door of your fuel-burning appliances
 - Moisture collecting on the windows and walls of furnace rooms
 - Fallen soot from the fireplace or small amounts of water leaking from the base of the chimney

A CO alarm should not be confused with a smoke alarm. A smoke alarm tells you to get out immediately. A CO alarm warns of a potential poisoning risk, usually long before symptoms are apparent, which allows you adequate time to get help. You need both life-safety devices in your home.

PERSONAL PROPERTY STATEMENTS DUE FEBRUARY 1, 2010

Personal property statements will be mailed in mid-December. This form is issued under authority of the General Property Tax Act. **Filing is mandatory.** Failure to file will result in an estimated assessment for 2010.

Failure to file this form by its due date will jeopardize your right to appeal and to file a Section 154 with the State Tax Commission. All sections must be completed.

MCL 211.19 States those personal property statements must be completed and delivered on or before February 1st of each year.

2010 CPI IS RELEASED

The numbers are in and the calculations have been made, it is now official: inflation for the last year was in the red. The State Tax Commission has announced that the official inflation factor to be used for calculating taxable values for the coming year is -0.3 percent. A negative inflation factor has never been used before in calculating the value of property for purposes of taxation.

The negative number means that the taxable value on every individual piece of property in the state must be reduced by a minimum of 0.3 percent. The only exception to this scenario would be pieces of property that transferred ownership in the past year and that still had a difference between the taxable value and state equalized value or property where construction has occurred.

TOWNSHIP SEEKS OPEN SPACE CANDIDATE SITES

Ada Township has voter-approved funds to use for the acquisition and permanent preservation of important open space lands in the community. All property acquisitions are on a voluntary basis with willing property owners.

For property owners who wish to keep their land undeveloped and also wish to retain private ownership, the Township will consider the option of purchasing a conservation easement on the property, a permanent deed restriction that requires the land to be kept in a natural, undeveloped condition.

The Open Space Protection Plan establishes priorities for the types and locations of open lands the Township would like to protect. High priority lands include:

- Land along the Grand River corridor.
- Agricultural lands in the northeast quadrant of the Township.
- Wetlands surrounding Chase Lake in the northeast part of the Township.
- Other lands with sensitive natural features, including wetlands, mature woodlands and stream corridors.

Property owners may apply to have their property considered for acquisition, or may nominate other properties for consideration. Donation of property to the Township is encouraged.

The 9-member Open Space Preservation Advisory Board reviews and recommends properties for acquisition. The Advisory Board meets regularly, and its meetings are open to the public.

Facility Use for Winter and Beyond

Ada Park Shelter & Gazebo Rentals and Reservations:

The Shelter and Gazebo at Ada Township Park are available on a first-come, first-serve basis April through October. To reserve the Shelter or Gazebo for your event there is a fee which varies by residency, type of organization and event. The Ada Covered Bridge is **not** rented out for private use. It must remain open to the public at all times.

Athletic Fields:

Athletic fields (baseball & soccer) at Ada Park and Leonard Field are used in the spring, summer and fall for area leagues and instructional programs. Contact the park office for information, schedules or reservations.

Ice Rink at Leonard Field

An ice rink is maintained in the winter at Leonard field for general use as weather allows. Note this is entirely dependent on the weather so check before using. It is open to the public for general skating at your own risk. Children need to be supervised by a parent or guardian.

Cross Country Trails

Cross Country Ski trails are set up at Roselle Park. They are available as weather allows. The trails start near the silos and extend through the north section of the park. Please do not walk on or allow dogs on the x-c ski tracks.

Walking & Bike Paths

Most of the paved paths in the parks will be plowed within 24 hours after each major snowfall. Note that conditions may be wet and/or slippery throughout the winter. At Roselle Park, only a section of the paved path will be maintained for the winter, allowing for x-c ski in the north section. Sections of the trails will be closed when flooded.

TRAIL CONSTRUCTION UPDATE

Work on the latest phase of Ada Township's non-motorized trail construction has wound down for the winter. Last summer and fall, the base layer of asphalt was completed on nearly all of the trail length between the north parking lot in Seidman Park and the McCabe Ave./Bailey Dr. intersection.

Work will continue through the winter on several sections of boardwalk located along Conservation St., between Honey Creek Ave. and McCabe Ave.

The top coat of asphalt will not be installed until asphalt production resumes again in the Spring of 2010. This work will include ensuring a smooth transition with existing driveways that are crossed by the trail. Final work will also be completed next Spring on landscape restoration along the trail route, and repair of any problems created during the winter months.

The Township Board will address budgeting of funds for completion of the trail down Bailey Dr. as it prepares and adopts the Fiscal Year 2010-11 budget in January-March of 2010.

The planned replacement of the M-21 bridge across the Grand River has been postponed by the Michigan DOT until 2011. Additional information regarding the estimated start and completion dates for this project and plans for management of traffic are expected to be provided by MDOT soon.
