The Farmers' Market Has Successful Season!

This is the third season for the new Ada Farmers' Market, and it has been a successful one! The number of vendors for the Market this year has grown to 40 vendors and many of them have come back to Ada every year since the first season.

There have also been some changes in the Market. Credit and debit cards, plus EBT/Bridge cards are accepted for the purchase of market tokens. The tokens can be used to purchase goods in the Market and have been so popular that the Market had to order more tokens! In addition we sold nearly 200 Market baskets—so successful that they are sure to return for the 2012 season



Hatatouille made its first appearance this season as a competition amongst the vendors for the best hat! Customers in the Market on August 2ND had the opportunity to vote on the best entry, and the winner was announced at the August 9TH market, with the prize being the waiver of that vendor's fee for the 2012 season along with the "el gran sombrero" trophy.

Before next season, the market will be launching a search for a new

"Market Master". The current and founding market master is Bob Kullgren, who is also the chair of the Downtown Development Authority, the sponsoring organization of the market. Bob will be stepping down as the purely "volunteer" market master as the DDA steps up to hire a replacement for Bob as a paid position. M-21 BRIDGE CONSTRUCTION UPDATE

Unusually-high water levels on the Grand River have resulted in a number of lost work days on the M-21 bridge project throughout the spring and summer months. A total of 40 days on pier work in the river have been lost due to high water levels, including, most recently, the period between July 30 and August 5. As a result, the project is about 6 weeks behind the original schedule, which called for completion of the new bridge deck by the end of November, 2011.

MDOT is working with the contractor to find ways to make up the lost time. If this can't be accomplished, it is likely that completion of the bridge deck and opening it to traffic will be delayed until April - May 2012, unless favorable weather conditions allow pouring of concrete pavement to take place during the winter months.

FALL 2011 LEAF PICK-UP DAYS

TIPS FOR A SAFER FALL SEASON

As the kids go back to school and the weather changes, we offer these important reminders for a safer fall season for back-to-school. If your child comes home from school before you get home from work, instruct him or her to never open the door to a stranger or let a phone caller know he or she is home alone. Also, make sure your child knows the code for your security system, so that his or her departure or arrival won't set off the alarm.

If your child walks to school or waits for the bus stop, wearing clothes that are brightly colored makes them more visible to drivers. Children that ride bicycles to school should always wear a helmet.

For Halloween

Leave a light on at the front door, and sweep your walkway clear of dead leaves or debris which might cause your guests to slip. Also, remove hoses and sprinklers from the lawn—children don't always use the sidewalk! (These tips are important anytime!!) Use battery-powered lights instead of candles for jack-o'-lanterns. And keep your jack-o'-lantern clear of people's paths.

Safety Tips for Fall Driving

With the fall season comes shorter days making it more difficult to see children playing or people walking and riding bicycles. It is also harder to see motorcycles and other cars. Children love to play in piles of leaves. Use extra caution where leaves are piled at curbside. Always drive carefully making sure to be aware of poor visibility during certain weather conditions and times of the day. Keep a safe distance from the car in front of you. Wet roads make it more difficult to stop. Use your dimmed headlights in bad weather with decreased visibility.

A NOTE FROM THE TREASURER...

Summer 2011 tax bills are due **in our office by 5:00 p.m., September 14, 2011**. After this time, penalty/interest will be added to all tax bills no exceptions. If you choose to make a payment through your on-line banking you **MUST** give your bank at least seven (7) business days to process and mail us the check. **POSTMARKS ARE NOT ACCEPTED** as date received.

If your taxes are escrowed, a mortgage company is listed on your bill and they have also received a copy of your tax bill. If so, please keep this copy for your tax records. Some mortgage companies utilize a taxing service to gather all of your tax information. If there is a different name or code on your bill other than your mortgage company, it will indicate the taxing service name that your mortgage company utilizes. **Example: If Fifth Third is your mortgage company, they may utilize CoreLogic Tax Service. On your bill the mortgage code is COREL.**

The usual payment options still apply; by mail, in person, by credit card (*see the reverse side of your tax bill for instructions*). Credit cards are **NOT** accepted at the Township. Additionally, you may sign up for ACH electronic payments. Please contact our office for more information about ACH.

Winter tax bills will be mailed the week of November 28, 2011. The due date for the winter tax is February 14, 2012 by 5:00 p.m. Remember **POSTMARKS ARE NOT ACCEPTED** as date received. All payments received in our drop box between December 30, 2011 and 8:00 a.m., January 3, 2012 will be posted as "received" December 31, 2011. After March 1, 2012 all unpaid real property taxes will be turned over to the Kent County Treasurers Office for collection.

Dog licenses for 2012 are available at our office starting December 1, 2011 through March 1, 2012. The State of Michigan requires all dogs age 4 months and older to be licensed. In order for a 2012 license to be issued, a current rabies certificate, and proof of neuter/spay must be presented. You can secure a copy of these documents through your veterinarian.

APPLICANTS SOUGHT FOR TOWNSHIP BOARDS AND COMMISSIONS

Much of the work of Township government is accomplished through its appointed Boards and Commissions. The members of these Boards and Commissions are Township residents from all walks of life who share one thing in common—a desire to serve the community.

The Township is currently seeking residents interested in serving on two of its important advisory Boards—the Open Space Preservation Advisory Board and the Planning Commission.

The 9-member Open Space Advisory Board is responsible for overseeing the Township's open space preservation program, and the expenditure of revenues from the voter-approved millage that is targeted specifically for preserving important open space land in the community.

Those interested in serving on this Board ideally will have an interest in and/or knowledge of natural history, botany, ecology, water resources, geography or another natural science. A familiarity with native plants of our region would also be helpful. A background in real estate also would bring valuable knowledge and skills to this Board.

The 7-member Planning Commission is charged with review and recommendation and/or approval of proposals for new development in the Township. The Planning Commission's decision-making procedures and protocol are sometimes referred to as being "quasi-judicial," in that development proposals are reviewed against criteria and standards contained in the Township's zoning regulations and in State statute. Decisions made by the Planning Commission must follow "due process" rules.

The makeup of the Planning Commission membership is required by State law to be "representative of important segments of the community, such as agriculture, natural resources, recreation, education, public health, government, transportation, industry, and commerce." The Commission membership should also be representative of the geographic

diversity of the community.

Both of these appointed bodies meet at least monthly in open public meetings. Serving on Sub-Committees and site visits require a commitment of time in addition to the regular monthly meetings.

GUIDELINES FOR TRAIL USERS – TRAIL ETIQUETTE

With the expansion of the Township's non-motorized trail system, it is important for trail users to be aware of how to use the trails in a safe manner. By following some simple guidelines for trail use, or "trail etiquette," the safety of all users can be assured. Help make our multi-use trails safe and enjoyable for everyone by using the following guidelines:

Be Courteous.

All trail users, including bicyclists, joggers, walkers, wheelchairs, skateboarders, bladders and skaters, should be respectful of other users regardless of their mode, speed or level of skill.

Be Predictable.

Travel in a consistent and predictable manner. Always look behind before changing positions on the trail.

Don't Block The Trail.

When in a group or with your pets, use no more than half the trail so as not to block the flow of other users.

Keep Right.

Stay as near to the right side of the trail as is safe, except when passing another user.

Pass On The Left.

Pass others, going your direction, on their left. **YIELD TO SLOWER AND ON-COMING TRAFFIC.** Use hand signals to alert those behind you of your moves. Look ahead and back to make sure the lane is clear before you pull out and pass. Pass with ample separation and do not move back to the right until safely past. **REMEMBER: KIDS AND PETS CAN BE UNPREDICTABLE.**

Stopping.

When stopping, move off of the trail. Beware of others approaching you from behind and make sure they know you are pulling over.

Give Audible Warning BEFORE Passing.

Give a clear signal by using voice, bell or horn before passing. Give the person you are passing time to respond. Watch for their reaction. So that you can hear these signals, don't wear headphones on the trail.

Obey All Traffic Signs And Signals.

Use extra caution where trails cross streets. Stop at all signs and intersections and be cautious when crossing driveways. When entering or crossing a trail yield to traffic on the trail.

Use Lights At Night.

Be equipped with lights when using a trail at any time from dusk to dawn. Bicyclists should have a white light visible from five hundred feet to the front and a red or amber light visible from five hundred feet to the rear. Other trail users should have white lights visible from two hundred fifty feet to the front, and a red or amber light visible from two hundred fifty feet to the rear.

Don't Use A Trail Under The Influence Of Alcohol Or Drugs.

Don't overestimate the safety of any trail. You may need all of your reflexes quickly—don't have them impaired.

Be Respectful Of Private Property.

Trails are open to the public, but often the land on the side of the trail is private property. Please respect all property rights.

Clean Up Litter.

Do not leave glass, paper, cans, plastic, or any other debris on or near a trail. If you drop something, please remove it immediately.

Have You Outgrown Trails?

Trails have engineering and design limits. If your speed or style endangers other users, check for alternative routes better suited to your needs. Selecting the right location is safer and more enjoyable for all concerned.

Always Exercise Due Care And Caution.

ADA TOWNSHIP ENCOURAGES SAFE CYCLING AND SHARING THE ROAD

Even though Ada Township has built a coordinated network of separated pedestrian/bicycle trails, there are many cyclists for whom riding in the road best suits their riding needs and abilities, as well as the interests of safety, even on roads that are adjoined by a separated path.

Drivers who encounter cyclists in the road should keep in mind that cyclists have the legal right to use the road, even when an off-street trail is adjacent to the road.

Drivers should approach and pass cyclists in a cautious, courteous and safe manner.

Cyclists who use the roads have a legal responsibility to abide by the same laws and rules of the road that apply to drivers, including riding with traffic and obeying traffic control signs. In addition, cyclists should signal their intended movements by using accepted hand signals, and should always wear a helmet.

Cyclists who are using the Township's separated, non-motorized trails should follow the guidelines for "trail etiquette" listed in the companion article in this edition of the ADAVIEW.
